## **Concept Note**

The Sustainable Development Goals (SDGs), established by the United Nations in 2015, emphasize gender equality as both a fundamental human right and a critical factor in achieving sustainable development. Goal 5 specifically calls for the empowerment of all women and girls, ensuring their involvement in decision-making processes, and eliminating discrimination and violence against them. Further, Goal 8 mentions about the decent work and economic growth it emphasizes on the requirement of decent work opportunities and to prevent exploitation of women. Human trafficking remains a constant hurdle for the decent opportunities worldwide.

Human trafficking is one of the most pressing human rights concerns in India today, and the North Eastern region has emerged as a particularly vulnerable zone due to its complex socio-economic, geographical, and political landscape. The porous international borders with Bangladesh, Nepal, and Myanmar; internal displacement; poverty; and lack of awareness make the region a source, transit, and destination point for trafficking, particularly involving women and children.

Tripura, due to its geographical proximity to international borders and significant tribal population, has been identified as a high-risk state. Despite national and international legal frameworks, trafficking continues to thrive through well-organized networks exploiting the lack of enforcement, poor victim identification, and inadequate rehabilitation mechanisms. Overcoming these challenges requires a collaborative effort across all sectors and disciplines, underscoring the vital role of collective action in achieving a more equitable, sustainable future for all.

## **Objectives**

- This national conference aims to create a platform for multi-stakeholder dialogue that will:
- Identify the patterns and scale of human trafficking in the North East, with a focus on Tripura.
- Evaluate the effectiveness of existing legal and institutional mechanisms.
- Highlight the role of law enforcement, judiciary, human rights bodies, NGOs, and academic institutions.
- Encourage the development of innovative, community-based and victim-centric approaches.
- Facilitate academic and policy-based research on trafficking issues in the region.

## Guidelines for Paper Submission

- The title of the paper should be followed by Name of the Author, Designation, Name of the Organization/University/Institution and Email address. It is mandatory to mention Email address, as all future correspondence will be through it.
- Name and details of Co-author, if any.
- The paper should be typed in MS WORD format.
- The paper must be in single column lay out with margins justified on both sides.
- The heading and sub-heading should be in font size 12 bold and Times New Roman, left aligned.
- The main text should be in font size 12 Times New Roman, 1.5 spacing and justified.
- The length of the paper should not exceed 6,000-8000 words (including footnotes). Exceeding the word limit may lead to rejection of paper.
- Citation Format should conform to the Indian Law Institute, New Delhi.
- Submission of the abstract should be accompanied by a covering letter with the name(s) of the author(s) and address, designation, institution/affiliation, the title of the manuscript and contact information (email id, phone number). All submissions must contain an abstract of not more than 250 words with 5 minimum key words.
- All the contributions should be the original work of the contributors and should not have been submitted for consideration in any other Publication. Any plagiarized work will be out-rightly rejected.
- All the contributors should provide a declaration form regarding the originality of the paper.
- The contributions presented to and accepted for publication and the copyrights therein shall be the intellectual property of National Law University, Tripura.
