SUBMISSION GUIDELINES

- 1. The Bill must be submitted by email to
- <u>competitions@klecollegeoflawmumbai.ed</u> <u>u.in</u>, with subject: Bill Submission for National Legislative Drafting Competition.
- 2. Submissions must be of minimum 10 pages and maximum 25 pages.
- 3. Font: Times New Roman, Size 12, 1.5 spacing, justified.
- 4. Up to 2 co-authors will be permitted. Both authors must register and pay separately.
- 5. The Bill will undergo a thorough AI and Plagiarism check, to ensure the submissions are original. Plagiarism is permitted only up to 30%.
- 6. The decision of the organizing committee shall be final and binding regarding the submission acceptance or rejection of Bills and the prize winners.
