# State of Surya Pradesh vs Mr. Sunder Sharma and others

#### Facts:

- In the early 2020s, Surya Pradesh State in the People's Republic of Rastrasangh was one of the wealthiest groups of people in the world due to the discovery of oil on their land. This newfound wealth, however, brought enormous danger. A series of brutal murders targeting the Surya Pradesh people unfolded in what became known as the "Reign of Terror." Surya Pradesh's laws are perimetria with those of the Republic of India.
- Mr. Sunder Sharma, a native of Surya Pradesh whose parents were foreign nations, controls lucrative oil rights. Mr. Sunder Sharma has close ties with Surya Pradesh's ruling political party, the "Krantikari Dal." Online reports accuse Mr. Sunder Sharma and others of heinous crimes related to the murder of oil-rich family members.
- Experts speculate that Mr. Sunder, in collaboration with his nephew Mr. Pinto Sharma and other accomplices, executed a string of murders aimed at eradicating the family members of individuals inheriting oil-rich land. Various methods, such as shootings, poisonings, and bombings, claimed the lives of the victims. Local authorities initially disguised these murders as accidents or health issues, making it difficult to detect the conspiracy.
- Mr. Pinto Sharma, one of Mr. Sunder Sharma's main allies, administered slow poison to his wife, Mrs. Rati Davi, to secure ownership rights over oil-rich land after her death. Mr. Pinto Sharma stated before the investigating agency that his wife Mrs. Rati Davi and her family adhere to traditional practices such as talking to spirits and using conventional medicines for cures, which he considered unscientific. He further claimed that her ill health was a result of her negligence and non-consumption of allopathic medicines.

- One day, Mrs. Rati Davi, without informing her husband, traveled to Indraprastham, the capital of Rastrasangh, seeking government support. She informed government agencies about the malpractices, organised crime in Surya Pradesh, and the unnatural deaths of oil-rich family members' heirs, particularly female ones. She also spoke about the involvement of her husband, Mr. Pinto Sharma, and his close ally, Mr. Sunder Sharma, in these incidents.
- As the death toll rose, the family members of oil-rich land, worried for justice, sought help from the central government, Rastrasangh. The central government handed over this case to the Bureau of Investigation (BI), led by former Inspector General Mr. Ajeet Kumar. The investigation uncovered a deepseated conspiracy and exposed the extent of Sunder's manipulation and greed. Mr. Ajeet and his team gathered substantial evidence through undercover operations and witness testimonies, revealing the true nature of the crimes.
- Mr. Sunder Sharma made a statement before the investigating agency that Native oil-rich family members are against him because they do not tolerate a person whose parents were from foreign nations controlling the lucrative oil industry in Surya Pradesh and making a good profit; therefore, they are making such stories and trying to kick him out of this business and want to control this oil industry by themselves only and the Constitution of Rastrasangh allows use of natural resources in national interest only, not for private benefits.
- Based on the gathered evidence, IB initiated a trial in a District Court in Suraya Pradesh, citing a direct violation of the fundamental rights of the legal heirs of native oil-rich families. The Court rendered a verdict in favour of Mr. Sunder Sharma and others, citing insufficient evidence against them that failed to meet the standard of proof beyond a reasonable doubt.
- A large number of murders in Surya Pradesh highlighted the systemic corruption and exploitation faced by the natives of Surya Pradesh State, as well as the need for legal protections and reforms. The case also marked a significant moment in the history of law enforcement, as it led to the strengthening of the BI and its role in fighting organised crime and safeguarding the fundamental rights of people. This case serves as a grim reminder of the greed-fueled violence that plagued the state of Surya Pradesh and the enduring quest for justice.
- As a result, the state decided to appeal to Rastrasangh's Supreme Court as this matter is related to violations of Fundamental Rights (Art 15(1), 19(1)(g), 21, 32, and 136.

- Fraudulent activities are crucial in deceiving and exploiting native oil-rich family members, enabling them to seize control of their wealth.
- The prosecution uses fraud, embezzlement, and unlawful inheritance laws against the accused.
- Domestic violence is systematically used to achieve malicious objectives.
- High-profile individuals are actively manipulating the issue of white-collar crime.

This moot court case challenges participants to address the complex legal, ethical, and jurisdictional issues surrounding the murders of the Surya Pradesh State members as depicted in this case. It raises critical questions about justice, exploitation, and protecting vulnerable communities in the face of greed and corruption. Participants must navigate the intricacies of criminal law, conspiracy, and Native of Surya Pradesh rights to seek justice for the victims and their families.

#### I. Aim & Purpose

 In addition to developing cutting-edge skills in research, writing, and advocacy, the Lakhmi Change National Moot Court Competition aims to foster opportunities for learning the development of jurisprudence on emerging trends in criminal law.

#### II. Venue and date

- The Lakhmi Chand National Moot Court Competition will be offline from September 27th to September 28th, 2024.
- Dr. Arun Verma, Dean of the Department of Legal Studies, LCIT College of Commerce and Science, Bilaspur, CG, will decide on any dispute that arises during this competition.

#### III. The competition shall be in English/Hindi.

#### IV. Eligibility

 The competition is open to students taking LLB threeyear or five-year courses during the current academic year who are interested in clinical law and can participate.

#### V. Team Composition

- Each team should consist of a minimum of 2 and a maximum of 3 members. Under no circumstances can we modify this number.
- For each team, there will be two speakers and one researcher. The researcher may petition the court and dean of law for permission if a speaker is ill.
- Each team will receive a unique team code during orientation. Teams should not disclose the identity of their institution; such disclosure will invite penalties, including disqualification. The decision for the same shall be at the discretion of the Dean of Law (LCIT).

#### VI. Registration

- Online registrations are open as of August 01, 2024. The teams must register online by September 10, 2022. Teams must register online using the provided web link, and the competition will only accept 50 teams on a first-come, firstserved basis.
- We will not entertain any requests for temporary registration.
   Kindly refrain from sending such requests to our official email ID, i.e., law@lcit.edu.in.
- Participants will receive a confirmation email as an acknowledgement of successful registration submission.
   Participants will receive approval as acceptance of their request for participation within a week from the date of their online registration.

#### **VII. Registration Process**

**Option 1:** The registration form (i) and approval letter (ii) as provided in the rules, duly signed and sealed by your university, college, or most committee.

**Option 2:** Upload both (i) and (ii) in a PDF file. (on registration link)

- (i) You should properly fill out and sign the registration form and approval letter as specified in the rules, without a seal.
- (ii) A scanned copy of the authorization letter with a sign and seal from your university institution or moot committee.

#### or

- To complete the registration process, send an email using the official ID of your university, college, or moot committee, which should serve as a notification email ID during the online registration process.
- Note: Students may use the library services for research purposes before 6:00 p.m. during the competition, and they may obtain a photocopy of the required material. However, they cannot take reference books or Bare Act outside the library.
- The college is not responsible for the lost research materials of the participants, so students must take care of their belongings.

#### VIII. ORIENTATION

• On September 27, 2024 (Friday), there will be an orientation programme for all participants, followed by a drawing of lots and an exchange of memorials. During the orientation, we will only assign competition team codes and sides.

#### IX. ROUNDS

- There will be two preliminary rounds of arguments: an octafinal, a quarterfinal, a semi-final, and a final round.
- If more than 24 teams are participating, we will hold an octagon. If the participation exceeds 16 teams, we will conduct a quarterfinal.
- There are three rounds: the preliminary round, the octafinals, and the quarterfinals.
- **a.** There will be two preliminary rounds of arguments per team, once for the applicant and another for the respondent.
- **b.** No team will face each other more than once in the preliminary rounds.
- In their second round of arguments, each team will face a different bench.
- We have scheduled the semi-finals for September 28, 2024 (Saturday), and the preliminary 1/preliminary 2/octa finals/quarterfinals for September 27, 2024 (Friday).
- The octa-quarterfinal rounds will determine which of the top sixteen/eight teams from the preliminary rounds advance to the octa-quarterfinal rounds.
- a. Win points
- b. Win points + aggregate raw points
- c. Win points plus aggregate raw points (in the event of a tie, fewer memorial marks). Only the scores from both preliminary rounds will count as memorial marks.
- f. The advocate's attire (as laid out by the BCI) shall be the dress code during orientation, the oral rounds, and the competition's valedictory ceremony.
- The oral arguments don't have to limit themselves to the topics discussed in the memorials.

#### Octa-final, quarter-final, and final round:

- A significant amount of power matching will determine the sides of the arguments in the octagonal, quarterfinal, semifinal, and final stages.
- The semifinals and finals will take place on September 28, 2024 (Saturday).
- The octafinal and semifinal rounds are knockout rounds.
- The schedule is subject to change if the participating teams' number is less than 24.

#### X. Results (Announcement)

 Once all teams have completed their preliminary rounds, we will announce the results. Similarly, we will announce the results of the quarter-final and semi-final rounds once all qualified teams have completed their respective rounds. We will announce the final round results during the valedictory ceremony.

#### XI. MEMORIALS

- We must strictly adhere to the following criteria for memorials: Non-conformities will be punished.
- Each team must prepare memorials for both parties to the dispute (the petitioner and respondent).
- On or before September 10, 2024, mail the soft copies of the memorials for the petitioner and the respondent to law@lcit.edu.in.
- We will penalise late submissions by two points per hour, with a maximum penalty of 20 points.
- If the team receives memorials after 24 hours of the deadline, they will lose the moot court competition.
- After submitting the soft copy of the memorials, we will not accept any revisions, supplements, or additions.
- Please email soft copies of the memorials with the subject "Team Code: Memorial Submission." You must submit the memorials in Word format. The file shall be named "Team Code: Memorial for Petitioner" and "Team Code: Memorial for Respondent," respectively. Attach the memorials for both sides as separate attachments within the same email communication.
- Type the memorials onto an A4-sized piece of paper, print them on one side, and include the following information:.
- 1. The table of contents
- 2. The index of authorities
- 3.A statement of jurisdiction
- 4. Keep the statement of facts to one page, as an argumentative statement could lead to penalties.
- 5. The statement of issues
- 6. The summary of arguments (not more than 1 page)
- 7. The arguments progressed, spanning no more than 15 pages.
- 8. The prayer

- The memorial should use a uniform font size throughout. The memorial should use the font "Times Roman" with a size of 12 (1.5 space), and for footnotes, the size should be 10 (single space), with 1.5 space between two footnotes. Footnoting must conform to the Bluebook: A Uniform System of Citation (20th Edition). Noncompliance will result in a penalty of 1 mark per page. We strictly prohibit the use of substantive or verbal footnotes.
- The memorial must have a margin measuring one inch on all sides of each page.
- The page numbering should be on the top right side of each page.
- You should arrange the covers on the briefs in the following manner:
- Petitioner: Light Blue; Defendant: Light Red.
- The memorial's cover page should include the following information:
- You can find the team code in the upper-right corner.
- The cause titles
- Identify the brief as either petitioners, applicants, or respondents, depending on the context.
- The memorial must not reveal the institution's identity to anyone. Violation of this provision shall result in penalties, including disqualification. The Dean of Law's (LCIT) decision will be final.
- The teams can collaborate on a separate 50-page paper book (compendium), containing all the annexures and case laws mentioned in the memorial. The paper book will have a white cover. According to the organizers' advice, teams may submit papers to judges or submit them during virtual registration before the competition starts. Any identifying mark or seal of the college or university shall attract severe penalties, including disqualification.

#### XII. ORAL ROUND

Preliminary Round, Octafinals & Quarterfinals

- Each team will get a total of 30 minutes to present their case. This time will include rebuttal and sur-rebuttal time.
- The division of time is at the discretion of the team members, subject to a minimum of 12 minutes per speaker. Before arguments begin, inform the court officer about the division of time.
- The issues presented in the memorial need not be the sole focus of the oral arguments.
- During the rounds, the researcher may pass notes to the speakers. However, the researcher must do this discreetly to avoid disrupting the court proceedings.
- The researcher has the option to sit alongside the speakers during the oral sessions.

#### XIII. Semifinals & Final

- Each team will have 45 minutes to present their case, which will include rebuttal and surrebuttal time.
- The time division is up to the team's discretion, with a maximum of 25 minutes per speaker and a minimum of 20 minutes per speaker.
- The issues presented in the memorial need not be the sole focus of the oral arguments.
- During the rounds, the researcher may pass notes to the speakers. However, the researcher must do this discreetly to avoid disrupting the court proceedings.
- The researcher has the option to sit alongside the speakers during the oral sessions.

#### XIV. SCOUTING

 Teams cannot watch any other team's orals. Scouting is strictly prohibited. Scouting by any of the team members will result in disqualification. However, all participants can watch the final round in the moot courtroom.

#### XV. SCORING

#### A. Orals

The parameters for judging the oral presentation on a scale of 0 to 100 points are:

- Knowledge of facts
- Logic and reasoning
- Organisation and clarity
- Persuasiveness
- · Deference to the court
- A thorough and well-articulated examination of the issues arising from the facts
- Gaining an understanding of the legal principles that directly relate to the issues at hand
- The ability to clearly explain legal principles in general while staying within the allotted time.
- Understanding and applying national law's legal sources, authorities, and general principles.
- Ingenuity (ability to argue by analogy from related aspects of law)

#### B. Written Submissions (Memorials)

- A scale of 1–100 points for each memorial is required.
- After submission, any revisions, supplements, or additions to the memorials shall incur severe penalties, subject to the discretion of the Dean of Law (LCIT).

We will award the points based on the following criteria:

- The text is neat, legible, and free of typographical or format errors.
- The logical progression of ideas
- To effectively outline arguments, use headings.
- Understanding essential legal issues presented
- Focus on essential (not collateral) issues.
- Clear, concise, and unambiguous writing style
- Forceful and persuasive presentation
- Integration of facts into legal argument
- Understanding the case's strengths and weaknesses is crucial.
- Discussion of viable alternative arguments
- Understanding and analysis of authority
- It is critical to use appropriate citations and citation forms.
- To effectively support arguments, use authority.
- Ability to distinguish adverse cases

Non-compliance with the rules mentioned in Clause VII above shall attract severe penalties
