The Bharatiya Nyaya Sanhita, for instance, modernizes the procedural aspects of criminal law, while the Bharatiya Nagarik Suraksha Sanhita, focuses on citizen protection and public order, and the Bharatiya Sakshya Adhinyam, revises the rules of evidence to incorporate technological advancements.
