

## GUIDELINES

#### **Guidelines for Essay:** The word limit for the essay writing segment is 2000 to 5000 exclusive of footnotes. For both individual

authorship and co-authors. The abstract shall be 300 words or less. The abstract is an option and is at the author's complete discretion.

#### Guidelines for Blogs:

The word limit for blog writing segment is 500 words to 1500 words exclusive of sources and citations. It applies for both individual authorship and co-authors. The style of writing for the blog is at the author's complete discretion.

#### Guidelines for Cases:

The word limit for the case commentary is 1500 words to 3000 words exclusive of footnotes.It applies for both individual authorship and co-authors.

The author can use other cases to support their points, but the highlighted case should be the choosen case by the author.
