The college has conducted various Moot competitions, essay writing competitions, and various other competitions throughout the years. The college has also been the host of various webinars and seminars.

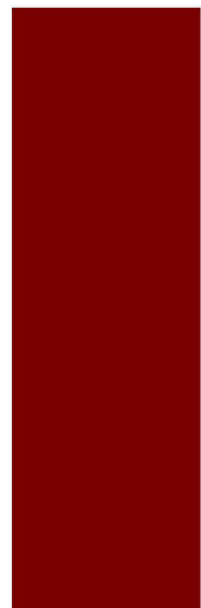
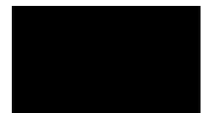


About The Moot

- Round 4 - Semi-Finals Round (Offline)
- Round 5 – Final Round (Offline)



RULES & REGULATIONS

TEAM COMPOSITION AND ELIGIBILITY



- Each team shall comprise two speakers and one researcher.
- Students from all law colleges/institutions/universities across the country recognized by the Bar Council of India are eligible to take part in the competition.
- All participants must be currently pursuing their bachelor's degree in Law, i.e., either 3-year or 5-year courses.
- Only one team per college shall be allowed to participate.
- The official language of the competition shall be English.

REGISTRATION DETAILS

- Registration shall be based on a first-come first-serve basis.
- Registration procedure shall consist of a provisional registration and a final registration.
- Each team shall provisionally register by filling out the **PROVISIONAL REGISTRATION LINK** by **22nd October 2024**. Teams must fill out the Google Form and make the payment only after the confirmation of provisional registration.

- Provisional registration after the given deadline shall not be accepted, under any circumstances.
- On completion of provisional registration, organizers shall intimate acknowledgment to the participating teams.
- The participating teams will have to register themselves through **FINAL REGISTRATION LINK** by **29th October 2024(11:59 pm)**.

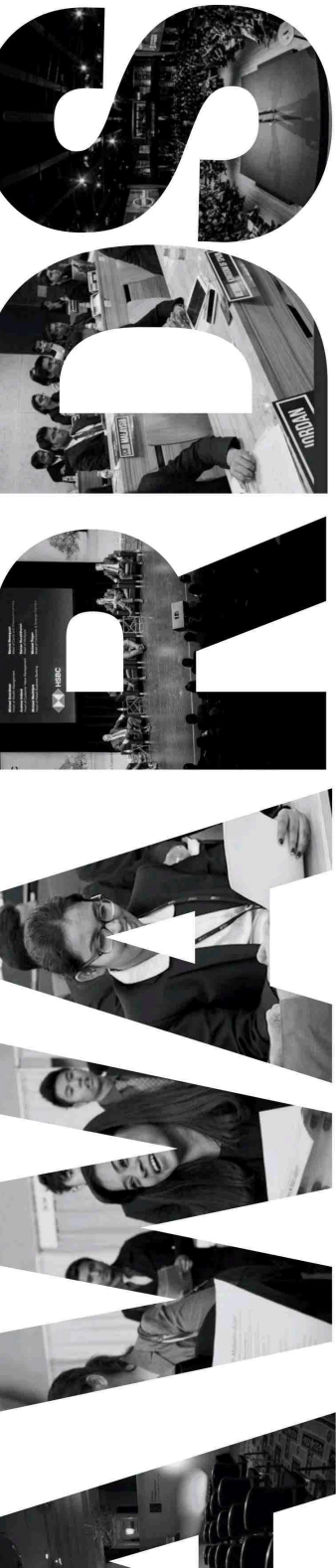
