# ABOUT THE UNIVERSITY

Dr. Ram Manohar Lohiya National Law University was established in 2005 by the Government of Uttar Pradesh under the U.P. Act No. 28 of 2005. The University is recognised by the Bar Council of India and the University Grants Commission. Despite being relatively new, the University has successfully produced skilled, dynamic, and socially responsible legal professionals and has become a leading institution for legal education in the country. The campus is spread over forty-two acres and boasts modern facilities, including the Madhu Limaye Library, which is considered one of the best in the country. Students have access to on-campus and off-campus legal resources and digital databases. ## GRADING SYSTEM

Each course is worth 100 marks. The overall structure of the distribution of marks in a theory-based course is that 20 marks are allotted to continuous internal assessment during the semester, 10 marks for attendance, and 70 marks for the end-semester examinations. Each course carries a weightage of 5 credits. The Semester Performance Index weighs the average performance in the semester, whereas the CPI weighs the same across the academic sessions attended/passed so far.

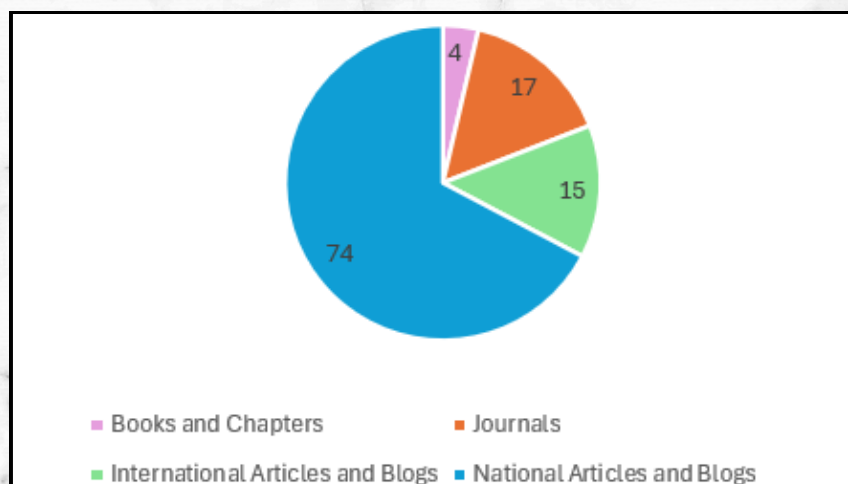

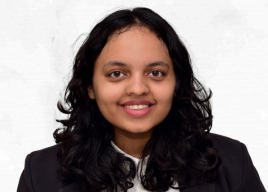

# RECRUITMENT PROCESS

## Register

The Recruiters are requested to register themselves with the Recruitment Co-ordination Committee through the Placement Cell Email ID with their preferred dates in the final placement schedule by filling out the recruitment form.

## Pre-Placement Talks

The recruiters are encouraged to conduct pre-placement talks highlighting crucial principle features of their organisation, job profile, terms and conditions of employment, remuneration, and other relevant information. The recruiters are urged to indicate their preferred dates for such talks to the Placement Cell either by e-mail or telephonic communication a week prior to their arrival.

## Screening Process and Final Interviews

The recruiters are at liberty to determine their eligibility criteria and the policy for the screening and recruitment process. Organisations can also opt for telephonic interviews and interviews via videoconferencing, and the Placement Committee shall facilitate their process as and when required. In case the recruiters do not want to conduct a pre-interview screening, the CVs of the interested and eligible students shall be forwarded to them before the final interview.

## Disclosure of Offers

The recruiters, after the final interview, shall declare the list of shortlisted candidates. This disclosure shall contain the job description, designation, remuneration, location, and other relevant terms and conditions of the employment. Offer letter(s), if any shall then be sent to the 'RCC' - acceptance or rejection of which shall be conveyed by the student directly to the recruiter. Such acceptance and rejection shall be in writing, marking the Recruitment Co-ordination Committee.
