

3RD NLUO – PHFI PUBLIC HEALTH LAW NATIONAL VIRTUAL MOOT COURT COMPETITION 2024

National Law University Odisha's Centre for Public Health Law in association with the Public Health Foundation of India organized the 3rd edition of the Public Health Law National Virtual Moot Court Competition from 7th - 10th September, 2023. The Moot problem dealt with the ongoing tussle between the public health issue of obesity and the private corporate interest to push for addictive 'junk' food. The competition saw participation from 90 teams from all across the country. From Partners to Senior Supreme Court advocates, over 80 eminent personalities of the legal fraternity judged the oral rounds over the course of 4 days.
