#### DEFINATIONS

For the purpose of the rules for this competition, the following words and expressions are used in the following senses, unless otherwise intended or expressed by the Organisers in the course of the competition:

- *"ADR Committee"* refers to the ADR Committee of the REVA University, Bengaluru.
- *"Caucus"* shall mean a private session that may be called by a Mediating Pair or by the Mediators.
- *"Competition"* shall mean the 1<sup>st</sup> City Level Mediation Competition, 2025.
- "Competition Rules" shall mean these rules of this Competition.
- *"Confidential Information"* or *"CI"* shall mean certain factual information in relation to a Competition Problem that is provided exclusively to only one party.
- *"Competition Problem"* shall mean any problem framed and circulated by the ADR Committee for use in any rounds.
- *"Eligible Team"* shall mean any team comprising three members, currently enrolled in a 5 Year or 3 Year law degree course in the same Institution at the time of the Competition
- *"General Information"* shall mean factual information with respect to a Mediation Proposition that has been provided to both parties for any round.
- "Host Institution" shall mean REVA University, Bengaluru.
- *"Judge"* shall mean any qualified individual nominated by the ADR Committee to assess and rate the efficacy of the Mediating Pair and the Mediator(s) in a mediation session, in compliance with the rules and regulations governing the Competition.
- "Mediating Pair" shall mean the Client & Counsel of any Eligible Team.
- *"Mediator"* shall mean the member of any Eligible Team, who is designated as a mediator for the Competition.
- *"Participating Team"* shall mean any Eligible Team which has completed the Final Registration of the Competition.
- *"Penalty"* shall include the deduction in marks or disqualification of participants or any other disciplinary action taken by the Organisers on the account of any violation of these rules.
- *"Problem Statement"* shall refer to the Competition Problem and Confidential Information in its entirety.
- "Registration Fee" refers to the fee to be paid by teams for participation in the Competition.
- *"Session Manager"* refers to a member(s) of the Host Institution designated as such, in charge of overseeing the smooth conduct of a particular competition round.
- "Organisers" shall mean the ADR Committee of REVA University, Bengaluru.
- *"Team Code"* shall mean the unique identification code that will be provided to the participating team upon final registration.

#### **GENERAL INFORMATION**

The 1st City-Level Mediation Competition is set for April 5, 2025.

The Dress code for Competition is Western Business Formal.

The competition is open to all law students enrolled in a 5-year integrated or 3-year LL.B. course any recognized university in the Bangalore region.

Each university may register a maximum of **two teams** for the competition.

By registering for the competition, all teams are deemed to have accepted and agreed to abide by the rules, regulations, and terms outlined in this document.

Upon successful registration, each team will be assigned a **Unique Identification Code (UIC)**, on **March 26, 2025**, which must be used for all communication and during the competition. Teams must maintain anonymity at all stages of the competition, and any disclosure of their identity may result in disqualification or penalties at the discretion of the Organizing Committee.

#### **REGISTRATION PROCEDURE**

Registration is limited to a maximum of 20 teams on a first-come, first-served basis.

Teams must complete the registration process by filling out the official online registration form by March 25, 2025. The registration form is available at: <u>https://forms.gle/B1xVHcYs17uQrbK18</u>

The registration form requires teams to specify the roles of each individual member. Once registered, teams will not be permitted to change their composition. Any exceptions may be granted solely at the discretion of the Organizing Committee upon showing valid reasons.

Teams are strongly encouraged to complete the registration at the earliest possible to secure their participation.

#### **TEAM COMPOSITION**

Each team shall consist of three members: a Client, a Counsel, and a Mediator.

Participants may switch roles within their team only with prior intimation and approval from the Organizing Committee.

#### **REGISTRATION FEES**

The registration fee for the competition is INR 2500/- per team.

This fee is non-refundable and must be paid by all registered teams.

No refund shall be granted under any circumstances unless the competition is officially canceled.

The Organizing Committee reserves the absolute discretion to refuse or cancel the registration of any team.

#### **PAYMENT METHOD**

Participants must follow the steps below to complete the payment of the registration fee for the **1st City-Level Mediation Competition, 2025**:

#### **COMPETITION STRUCTURE**

**Qualifier Round:** All participating teams will compete in the qualifier round. The top **6 teams** securing the highest aggregate marks shall qualify for the **Semi-Final Round**.

**Semi-Final Round:** The **6 qualified teams** will compete in the Semi-Final Round. The **top 2 teams** securing the highest aggregate marks shall qualify for the **Final Round**.

**Final Round:** The **2 best-performing teams** from the Semi-Final Round will compete in the Final Round. The team securing the highest marks in the Final Round shall be declared the **Winner** of the competition.

#### DRAW OF LOTS

The draw of lots for the Qualifier round will take place on the day of the competition.

Teams will determine their roles (**Requesting Party or Responding Party**) through the draw of lots to ensure **fairness and transparency**.

Match-ups for the preliminary round will also be decided through the draw of lots.

#### CAUCUS

A private caucus is a confidential session held between the mediators and one of the mediating parties, without the presence of the opposing party.

The caucus provides a platform for the mediating party to share information privately with the mediators that may strengthen their case or offer valuable insights.

The mediating parties may request a private caucus at the beginning of the session during their introduction.

If the mediators consent, the caucus may be called at any point during the session as needed.

Once the private caucus concludes, volunteers will prompt the opposing parties to rejoin the main session, resuming the mediation.

#### TIME LIMITS

Each mediation session, including the except final round, will have a **60-minute time limit** to ensure efficiency and effective dispute resolution.

Any extension beyond the allotted time is strictly at the discretion of the assessors.

All teams must report to the mediation hall 20 minutes before their scheduled session.

Late arrival may result in negative marking or disqualification, at the discretion of the faculty coordinator of ADRC and the assessors.

#### Session Breakdown (Per Round):

- **Opening Statements by Mediators:** 2.5 minutes each (Total 5 minutes)
- Joint Mediation Session: 24 minutes

- **Private Caucus:** 4 minutes per team (Total 8 minutes)
- **Post Joint Mediation Session:** 14 minutes
- Concluding Remarks by Mediators: 2.5 minutes each (Total 5 minutes)

No additional time will be granted beyond the allotted 60 minutes.

Assessors may, at their discretion, allow a 2-minute buffer in exceptional circumstances.

Participants exceeding the allocated time will be penalized through negative marking.

#### Note:

- The **Final Round** shall have a total duration of **1 hour 15 minutes**.
- The above time limits may be modified on the day of the competition at the **discretion of the Organizing Committee**.
- The Organizing Committee reserves the right to **amend the time limits** based on necessity and time constraints.

#### INTERPRETATION OF THE MEDIATION PROPOSITION

The General Information (GI) and Confidential Information (CI) for the competition problems will be provided on the day of the competition.

Teams must rely solely on the facts provided in the competition problem. Neither the mediating parties nor the mediators are permitted to introduce new facts or modify existing ones but may draw reasonable inferences from the given information.

Any deviation from a reasonable interpretation of the mediation proposition may result in a penalty. In case of any doubts regarding the interpretation, the decision of the Competition Administrator shall be final and binding.

The Organizing Committee retains the exclusive authority to regulate all aspects related to the competition problem.

#### **SCORING CRITERIA**

Throughout the competition, Mediating Teams (Client & Counsel) and Mediators will be evaluated individually and may qualify for successive rounds independently of each other.

The assessment criteria for Mediating Teams and Mediators will be detailed in the official scoring sheets provided to the judges.

#### **Tie-Breakers:**

#### **Mediating Teams:**

In case of a tie in scores during the Preliminary or Knockout Rounds, the team advancing to the next round shall be determined based on:

• Higher number of score sheets indicating a "win".

• Greater points scored during the joint session.

#### **Mediators:**

In case of a tie in scores during the Preliminary or Knockout Rounds, the mediator advancing to the next round shall be determined based on:

- Higher cumulative scores earned during the Private Caucus.
- Greater points scored in the Opening and Closing Statements.

The Organizing Committee's decision on all scoring matters shall be final and binding.

#### **RANDOM PAIRING**

During the Qualifier Round, a Mediator from a team shall not, under any circumstance, be paired with the Mediating Pair (Client & Counsel) of the same team to maintain fairness and impartiality.

In the Semi-Finals and Final Round, pairings will be conducted randomly. As a result, there may be instances where a qualifying Mediator and a qualifying Mediating Pair from the same team are grouped together.

The Organizing Committee retains the discretion to make necessary adjustments to ensure the integrity and fairness of the competition.

#### MARKING SCHEME

Each participant will be evaluated based on the following criteria, with a total of 25 points per role:

#### 1. Mediator (25 Points)

- **Opening Statement** Clarity in setting the tone, explaining the mediation process, and establishing ground rules (5 Points)
- **Confidentiality & Trust-Building** Ensuring confidentiality and creating a secure environment for open discussions (5 Points)
- Time Management Efficiently managing the session while allowing balanced participation (5 Points)
- Facilitation & Cooperation Encouraging productive discussions and assisting parties in reaching an agreement (5 Points)
- Impartiality & Neutrality Maintaining fairness, avoiding bias, and ensuring both parties feel heard (5 Points)

#### 2. Counsel (25 Points)

- **Opening Statement** Clear and structured introduction outlining key interests and objectives (5 Points)
- Utilization of Confidential Information (CI) Strategic and ethical use of confidential facts to strengthen negotiations (5 Points)
- **Collaboration & Teamwork** Effective coordination with the client and mediator to achieve a favorable resolution (5 Points)

- Legal & Strategic Competence Demonstrating understanding of legal aspects and applying negotiation tactics effectively (5 Points)
- Negotiation & Problem-Solving Ability to develop creative, interest-based solutions (5 Points)

3. Client (25 Points)

- Opening Statement Effective articulation of concerns, expectations, and interests (5 Points)
- Utilization of Confidential Information (CI) Thoughtful use of confidential data to advance their position (5 Points)
- Knowledge of Facts Demonstrating awareness and clarity regarding the case details and issues (5 Points)
- Collaboration & Cooperation Working effectively with counsel and engaging constructively in mediation (5 Points)
- Negotiation & Flexibility Willingness to explore solutions and adapt to the evolving discussion (5 Points)

**Note:** The decision of the assessors shall be final and binding. The Organizing Committee retains the right to modify the evaluation criteria if necessary.

#### INTERPRETATION CLAUSE

The Organizing Committee reserves the exclusive right to interpret these Rules and Procedures as it deems appropriate to uphold fairness and equality for all participants and stakeholders in the Competition. The Committee's interpretation shall be final and conclusive. Any decision regarding the application of these Rules and Procedures shall be binding on all participants and stakeholders.
