- **Word Limit:** 2500-3000 words
- **Abstract:** Not exceeding 250 words
- **Format:** PDF only
- **Font:** Times New Roman, Size 12, Line Spacing 1.5
- **Margins:** 1 inch (2.54 cm) on all sides
- **References:** Must be included
- **Language:** English
- ✦ **Footnotes & Referencing:**
 - MLA format for citations
 - **Footnote Font:** Times New Roman, Size 10, Line Spacing 1.0
- ✦ **Co-authorship:**
 - Allowed up to 2 authors per entry
 - Only one submission per author/team
 - Multiple submissions (both as single author & co-author) will lead to disqualification
- ✦ **Submission Process:**
 - Submit via Google Form (Link will be provided)
 - Submissions will only be accepted after successful registration
 - Once submitted via Google Form, no modifications will be allowed
- ✦ **Plagiarism & AI Content Policy:**
 - Incomplete, plagiarized, or AI-generated submissions will be summarily rejected
 - Similarity limit: 15% (excluding footnotes)
