NATIONAL LAW UNIVERSITY AND JUDICIAL ACADEMY, ASSAM

National Law University and Judicial Academy, Assam (NLUJAA), was established by the Government of Assam through the National Law School and Judicial Academy, Assam Act, 2009 (Assam Act No. XXV of 2009). The institution was renamed in 2011 through an amendment replacing "School" with "University." The Chief Justice of the Gauhati High Court, Hon'ble Mr. Justice Vijay Bishnoi, serves as its Chancellor.

NLUJAA offers modern legal education and research opportunities to students from diverse backgrounds across India, including the Northeast. With strong support from the Assam government, the university operates on a 50-acre campus in Amingaon, situated along the northern banks of the Brahmaputra River. It currently has around 300 students enrolled in its BA LLB (Hons), LLM, and PhD programs.

NLUJAA continues to evolve with a strong commitment to redefining legal education while actively shaping the legal landscape in India, particularly in the Northeast region. Through academic excellence, research initiatives, and engagement with contemporary legal challenges, the institution strives to foster a new generation of legal professionals equipped to drive meaningful change.

The Vox Anatolis Moot Court Competition ("The Voice of the East") organised by NLUJAA, uniquely focuses on legal issues pertinent to Northeast India. Designed to engage law students nationwide, it provides a platform to explore the region's legal complexities.

Previous editions have addressed significant legal and policy matters, including the National Register of Citizens and Biodiversity Laws of Assam, attracting widespread participation. Building upon the success of the first three editions, both regionally and nationally, we are pleased to introduce the fourth iteration of this moot in 2025.

With a vision to strengthen the mooting culture in Northeast India, this edition marks the beginning of a long-term initiative to promote legal scholarship in the region. DETAILS



Eligibility

The Competition is open to students pursuing an undergraduate degree in law from a recognised institution. There is no limit on the number of teams from the same institution.



Registration Fee
