- The extended abstract should contain 1000 to 1200 words (must include 4 to 5 relevant keywords).
- The extended abstract must be in Times New Roman font with 12-point size (English) & in Nirmala UI font, 10-point size (Hindi), with 1.5 line spacing, justified alignment and 1 -inch margin all round.
- The extended abstract must be original and not submitted elsewhere for any sort of publication, and must be free from any form of plagiarism.
- There should be no use of any AI model for content.
- The first page of the abstract must clearly mention following- Title of the Manuscript, Name of the Author(s), Designation, Name of the Institute/University/Organization, Email Address and Contact Number.
- No TA/DA and Accommodation will be provided.
- Certificates will be provided to all registered participants.
- Both Online & Offline Participants are welcome to contribute.
