ABOUT THE CONFERENCE

The Insolvency and Bankruptcy Code, 2016, was enacted by the Indian Parliament and received Presidential assent on 28th May 2016, aiming to provide time-bound resolution for entities facing financial distress. It consolidates insolvency and bankruptcy laws, which were previously scattered across various legislations, offering quick remedies for debtors, creditors, and employees.

Since its enactment, the Code has undergone multiple amendments. While it remains a key legislation for resolving insolvency and benefiting stakeholders, its implementation has faced challenges over the past eight years. Some issues have been addressed through amendments, but several continue to affect its functioning.

The Two-Day International Conference aims to explore the evolving insolvency landscape in India and beyond, bridging the gap between theory and practice. It will bring together professionals, researchers, and students to discuss critical aspects of insolvency practice.

SUBMISSION GUIDELINES

ABSTRACT SUBMISSION

- An abstract of 300–400 words must be submitted on or before June 30, 2025.
- The abstract should clearly mention the title, central idea, structure, and key conclusions of the paper, highlighting its novelty, usefulness, and specific contribution to existing literature. It must include the name(s), designation, email ID, and contact number of the author(s).

AUTHORSHIP

- Co-authorship is allowed for research papers, with a maximum of two authors.

FULL PAPER SUBMISSION

- Title: Times New Roman, 14 points, BOLD CAPS, centered.
- Text: Times New Roman, 12 points, 1.5 spacing, justified.
- Footnotes: Times New Roman, 10 points, single spacing, justified.

CITATION STYLE

- All citations must strictly follow Bluebook (20th Edition) for the conference paper submissions.

ACADEMIC INTEGRITY

- Submission must be original and unpublished work of the author(s). All manuscripts will be subject to similarity (20%) and AI evaluation. Use of generative AI will result in immediate disqualification from the conference

PUBLICATION

- Selected papers may be published at the discretion of the University. The decision of the University in this matter shall be final and binding. Only those papers which are submitted within the prescribed time-line shall be considered for publication.
