


## ABOUT T. S. MISHRA LAW SCHOOL

#### ABOUT THE LATE HON'BLE MR. JUSTICE T.S. MISHRA



The Late Hon'ble Justice Tribeni Sahai Mishra was born on 15th November 1922 to a well-known family of Mahona, Lucknow. Being the eldest child and displaying a scientific aptitude very early in life, he completed his intermediate education in science and mathematics from the government jubilee college. He was married in the year 1940 to Dr. Shakuntala Mishra in whose memory the state government of Uttar Pradesh established a university for the especially abled i.e. Dr. Shakuntala Mishra national rehabilitation university, Lucknow. While studying at Allahabad University he threw himself into the Quit India Movement of 1942 for which he was imprisoned in a cell having the Late Hon'ble Justice Yashdodandan a former judge of the high court as a cell mate. A year later, he graduated from the Allahabad University. He completed his post graduate studies with dual degrees of M.A. (English) and L.L.B with distinction from the University of Lucknow in the year 1945. A keen sportsman, he captained both the badminton and football teams of the university. He began his professional career as a legal practitioner in civil matters at Lucknow under the mentorship of advocate Mohd. Abbasi. Thereafter he branched out into company Secretaryship working at Kalyan Mills, Ahmedabad, and subsequently at Indu Mills in Mumbai. At heart he always remained an academician and an educationist, which motivated him to start his teaching career as an assistant professor of law at Kanya Kubj college, Kanpur while concurrently resuming his legal practice under Pt. Babu Lal Misra. He was subsequently promoted to the post of the dean faculty of law at the Kanya Kubj College. Given his legal acumen and professional knowledge, he was appointed as the District Government Counsel (D.G.C.) by the state government in the year 1964 and subsequently was elevated as a judge of the Allahabad High Court in the year 1971.

He remained a senior judge at Lucknow Bench of Allahabad High court and went on to become the Chief Justice of Guwahati High Court in 1983. Justice T. S. Mishra also functioned as the governor of Assam and Meghalaya. He, subsequently retired on 14 November 1984. In the year 1986 Justice Mishra was appointed as the ombudsman (Lokayukta) Bihar. He finally retired from active service in 1991. After his retirement from active service, he settled down in Lucknow to spent time with his family; the next generation of which was moving ahead with distinction. He spent the rest of his life enjoying the company of his youngest son Shri Satish Chandra Mishra (Founder and Chancellor, T. S. Mishra University) little knowing that the latter would be instrumental in establishing a university to immortalize his journey in life for all future generations.



#### ABOUT THE CHANCELLOR



Shri Satish Chandra Mishra, senior advocate and former advocate general of Uttar Pradesh was born on 9th November 1952 in Kanpur. He comes of an eminent family. His late father Justice T.S. Mishra Was Chief Justice of Guwahati High Court Governor of Assam and Meghalaya and Lokayukta of Bihar. His mother Dr. Shakuntala Mishra was a homeopathic doctor and Ayurvedacharya besides having remained as a teacher after obtaining degree of M.A., B.ed.

After graduating from Allahabad University and obtaining LL.B. Degree with distinction from Kanpur University Shri S.C. Mishra did Articleship of Chartered Accountant with B.C. Jain and Company at Kanpur during the period 1973-1976 and passed intermediate of chartered accountancy. He joined the legal profession in the year 1976 at Kanpur on criminal side and then shifted to Lucknow in the year 1977 and started practicing law at the High Court, Lucknow Bench, Lucknow.

Sri S.C. Mishra is blessed with distinguished career in the legal profession. He was appointed addl. Standing counsel of government of India income tax department in the year 1983. Thereafter he was appointed senior standing counsel of income tax department in the year 1986 of High Court, Lucknow bench, Lucknow and continued as such till he assumed the officer of Rajya Sabha member.

Shri S.C. Mishra is a prominent member of the bar and has many glorious achievements to his credit. He was elected Secretary, Oudh Bar Association, Lucknow bench in the year 1990 and was elected member of U.P Bar Council in the year 1994. Thereafter he was elected as chairman of U.P. Bar Council in the year 1998 and was designated as a senior advocate in the year 2000. At the age of forty-nine years Shri S.C. Mishra was appointed as advocate general Uttar Pradesh with effect from 5th may-2002. In June 2004 Sri S.C. Mishra was elected as member of parliament (Rajya Sabha) from Bahujan Samaj Party for a period of 6 years. He is also the All-India National General Secretary of Bahujan Samaj Party which is a national party as recognized by the election commission of India. In May 2007 he has been made as the leader of the B.S.P. Legislative Party in Rajya Sabha. Sri S.C. Mishra's modesty, integrity, pleasing personality and legal knowledge ensure for him a very bright future.

#### **TRAIL ADVOCACY MOOT PROBLEM**

Located in Southeast Asia, the Indiana Union is an independent, democratic nation. Because of the socioeconomic aspects of the nation, affirmative action has always been supported by the drafters of the constitution to help women and other underprivileged groups in our society. The general penal law of Indiana is the Indiana Citizen Code. It is a comprehensive code that was enacted in 2023 and was created to address every significant aspect of criminal law. Since it went into effect in 2024, the Act has undergone numerous amendments. Currently, more special criminal provisions are added to the Act by replacing the old act Indiana Penal Code, 1860.

Dolly, is a 23 years old girl, graduated from Ban Dosco School of Law University, New Gram in 2017 with an LL.B. degree. After searching for a good match for a very long time, Dolly's parents were thrilled when her marriage got fixed and it was held in Poshnagar, on April 25, 2018 which is situated in the capital city of Indiana, New Gram. The groom, Sunny is a Businessman and a property dealer. Sunny's father is a wealthy business tycoon who has significant political clout in the city. The wedding of Dolly and Sunny was a lavish event held in New Gram. The happy couple was blessed by visitors and family from all across the country. Dolly went to her in-laws' home in Joshpur, New Gram, after being married.

At the time of marriage, Dolly's father gave an AMW car, clothes, utensils, jewellery, furniture, and other household things as dowry. He also gave 1 crore cash to his son-in-law, out of which 50 Lakhs were invested as fixed deposit in Vanara Bank in the name of Dolly by her husband. The couple resided happily in their matrimonial home and even went to vacations several times. In between these times Dolly discovered that Sunny is an alcoholic and before marriage he was going through a rehab in a "Jan Nasha Mukti Kendra" in New Gram. After one year later, when Dolly came to her father's house for a ceremony, she was silent and had marks of assault on her body. When Dolly's mother asked her about the above-mentioned injuries, she told her that her in-laws were demanding cash and when she refused, they beat her a lot. After this incident Dolly took two lakhs cash and went back to her husband's house. These incidents happened to be reported by Dolly to her parents frequently and continued to happen. Dolly's parents tried to talk through this to Sunny's parents but it was of no use & due to the political influence of Sunny's father they couldn't approach the police or take any other recourse to resolve this. But at 2 O'clock on 2<sup>nd</sup> February, 2024 Dolly's father received a call from the Police Station Joshpur informing him that his daughter and son-in-law are in police station. When Dolly's father went to the Police Station, he found Dolly in a very vulnerable state, badly beaten and assaulted and Sunny was in a drunken state and unable to process what was happening.

Dolly informed her father that Sunny came very late at night in a drunken state and started physically assaulting her with his legs to her private parts. In order to save her from the life-threating assault, she hid in bathroom and called 112 for police help. Later there was compromise between Dolly and her husband that he will never repeat such acts again. These incidents have impacted the metal health of Dolly and she was diagnosed with clinical depression by Dr. Rustom Gonsalves, Doctor, Joshpur Hospital. Few days after the compromise Sunny called his mother-in-law at 4 O' clock in the early morning on March 7, 2024 that Dolly had died and informed that she had hanged herself. The police were there and conducting their inquiry when Dolly's parents arrived at her in-laws' house. According to the police officer, Dolly's husband contacted and reported the unfortunate incident to the authorities.

In addition to recounting all the instances of assault against Dolly for dowry, Dolly's mother informed the police officer on 7<sup>th</sup> March, 2024 that Dolly could never commit suicide because she is a lawyer and very brave girl who can fight for her rights. An FIR was subsequently filed by the police against Sunny and her in-laws under sections 80, 85, and 108 of the BNS, 2023 in relation to section 3 and section 4 of the Dowry Act of 1961. The police started looking into the situation and took notes from every potential witness.

The provisions of Indiana Union's law are pari materia with the Indian Law.

#### Summary of Facts & Evidence:

Dolly's marriage to Sunny was solemnized on April 25, 2018, during which her father provided dowry worth over  $\gtrless1$  crore, including cash, jewellery, a car, and household items, with  $\gtrless50$  lakhs kept as a fixed deposit in Dolly's name. However, soon after the marriage, Sunny's alcoholism and abusive behavior surfaced, leading to repeated physical assaults and dowry demands. Dolly reported these incidents to her parents, showing visible injuries from beatings, and even filed a police complaint on February 2, 2024, after Sunny brutally assaulted her in a drunken state. Despite a compromise, the abuse continued, pushing Dolly into clinical depression, as diagnosed by Dr. Rustom.

On March 7, 2024, Sunny called Dolly's mother at 4 AM, informing her that Dolly had "hanged herself." Upon arrival, Dolly's parents found her dead, with the police already present. Given Dolly's legal background, strong will, and absence of a suicide note, her mother firmly stated that Dolly would never commit suicide, raising strong suspicions of foul play. Dr. Rustom's records confirm Dolly suffered from depression due to marital abuse. Previous injury reports document the physical violence inflicted by Sunny. Postmortem findings determine that the death was due to the hanging. Bank records prove the ₹50 lakh FD in Dolly's name, likely demanded by in-laws. Statements from Dolly's parents confirm repeated demands for additional cash. History of abuse indicates Dolly was driven to suicide. Sunny's drunken violence just weeks before death establishes motive.

#### Charges on Accused No. 1 to Accused No. 4

- a) Section 85 BNS (Cruelty by Husband/Relatives)
- b) Section 108 BNS (Abetment to Suicide)
- c) Section 80 BNS (Dowry Death)
- d) Sections 3 & 4, Dowry Prohibition Act, 1961

Given the prolonged abuse, financial exploitation, and suspicious circumstances of Dolly's death, this chargesheet proves beyond reasonable doubt that Sunny and his family are guilty of dowry harassment, domestic violence, and abetment to suicide.

#### STATEMENT OF THE WITNESSES u/s 180 BNSS

- I. Brief facts of the case to be treated as the statement of the investigating officer. The investigation began which led to the discovery of evidence attached herein: recording of statements from witnesses. The accused is in judicial Custody. The police began investigation on the matter and records the statements of all possible witnesses.
- Sunny Watt (Accused No.1)- my marriage with Dolly was arranged through a II. middleman. She was highly educated, but soon after our wedding, her behavior became increasingly erratic and concerning. She would often act strangely—hurting herself and bursting into loud, uncontrollable laughter for no reason. Worried for her well-being, my family and I took her to a psychiatrist, but even the doctor's treatment failed to improve her condition. When we tried to discuss her mental health with her parents, they dismissed our concerns and instead threatened to falsely implicate us in a dowry harassment case if we persisted. On the day of the tragic incident, I was at my jewellery shop while my parents were resting at home. I received a frantic call from my mother saying Dolly had locked herself in her room and wasn't responding. I rushed home immediately and, finding the door bolted from inside, broke it open in panic. To my horror, I saw Dolly's lifeless body hanging from the ceiling fan. Devastated and in shock, I acted swiftly—I called an ambulance and the police right away and also informed Dolly's mother about the heart breaking situation. I have fully cooperated with the authorities since that day, but I am deeply anguished that instead of understanding the truth, I am being wrongfully accused. Dolly's mental struggles were real, and her family's refusal to acknowledge them has led to this tragedy. I never harmed her, nor did my family ever demand dowry. I am innocent, and I urge the investigators to look into Dolly's medical history and her parents' threats to uncover the real facts.
- III. Susan Watt (Accused No.2)- From the depths of my anguish, I make this statement - my son Sunny is an innocent soul trapped in a cruel fate. His only fault was marrying that mentally unstable woman who has now destroyed our family. From the very beginning, Dolly showed signs of madness - she would push me off my

bed and laugh hysterically, threaten to hang us all if we refused her demands, and deliberately provoke Sunny. My simple, quiet son never raised his hand on anyone until her constant taunts drove him to drink. Her family knew well about her unstable mind, yet they conspired against us. They would openly threaten to file false dowry cases if we complained about her behavior. Now their evil plan has succeeded - they've made my son a drunkard, driven his wife to suicide, and got us imprisoned on fabricated charges. That ₹50 lakh fixed deposit? It was their own idea to secure their daughter's future, not our demand. The police never bothered to check how she used to scream and throw things at home, or how her family blackmailed us for years. Today, as I sit in this jail cell for a crime we never committed, I ask only for God's justice. My son never touched that woman in anger - it was always her hitting him, abusing us, and threatening suicide. Now she's gone and taken our honor with her. I swear on my dead ancestors - we are innocent victims of a calculated plot by her powerful family. All I beg is for someone to see the truth behind this tragedy.

IV. Ramon Watt (Accused No. 3)- I wish to provide my account of these unfortunate events to assist the investigation. Our family welcomed Dolly with open arms when she married my son in April 2018. All the gifts and cash given during the wedding were voluntarily provided by her parents - we never made any demands. While it's true that my son struggled with alcohol issues, we always encouraged him to seek treatment and never condoned any violent behavior. The allegations of ongoing dowry demands are completely false. Whatever financial transactions occurred between the families were normal exchanges that happen in every marriage. Regarding the incident in February 2024, I acknowledge there was a marital dispute that night, but it was grossly exaggerated. My son may have argued with Dolly, but he would never physically harm her. We resolved the matter peacefully when the police came. The tragic events of March 7th came as a complete shock to our entire family. We were all asleep when it happened, and my son was the one who discovered Dolly and immediately alerted everyone. We're at a loss to explain why she would take such a drastic step, as she never showed any signs of being suicidal. Our family has fully cooperated with authorities from the beginning because we have nothing to hide. I understand Dolly's parents are grieving, but their accusations against our family are baseless and hurtful. My political standing in the community has nothing to do with this case, and I resent any suggestion that we've used

influence to obstruct justice. We're equally devastated by this tragedy and want the truth to come out, whatever it may be.

- V. Betty White (Accused No. 4)- my sister-in-law Dolly was an uneducated woman with clear mental health issues. Her behavior was often erratic she would obsessively sweep the same spot repeatedly and exhibit other strange mannerisms that concerned our entire family. On the day of this tragic incident, I was not present at home. I received an urgent call from my father and immediately rushed to Joshpur from my own residence. By the time I arrived, the authorities were already at the scene. I am completely shocked by what happened and devastated for both families. The allegations against me are entirely fake I had no involvement in this matter whatsoever, as I wasn't even present when this tragedy occurred. My brother and parents have always been kind, caring people who tried their best to help Dolly despite her mental health challenges. I urge the investigators to consider the truth about Dolly's psychological condition and recognize that I have been wrongfully implicated in this case.
- VI. Benedict Amrest (Prosecution Witness-1 Dolly's father)- I am the grieving father of my beloved daughter Dolly, who was brutally murdered by her husband Sunny and his family under the guise of suicide. When Dolly last visited us for a ceremony, she was unusually silent and bore visible injury marks on her body. When my wife asked about these wounds, Dolly broke down and revealed that her in-laws had mercilessly beaten her for refusing to give them more cash. Heartbroken but fearing for her safety, we reluctantly allowed her to return with 2 lakh rupees, hoping this would protect her. Just one week later, we received the devastating call from Sunny claiming Dolly had hanged herself. When we rushed to their home, we found police already present, who informed us that Sunny had reported it as suicide. But I know my daughter - a bright, strong-willed law graduate would never take her own life. My wife told the police officer the truth: that this was not suicide but cold-blooded murder by Sunny and his family, who had been torturing Dolly for more dowry since her marriage. We shared all evidence of their harassment - the beatings, the constant demands for money, and how they drove our daughter to despair.
- VII. **Sofia Amrest (Prosecution Witness-2, Dolly's Mother)-** I am the heartbroken mother of my beloved daughter Dolly, who was brutally tortured and murdered by her husband Sunny and his family for dowry. From the very beginning, my daughter suffered unimaginable cruelty at their hands. When Dolly came to our home for a

ceremony last year, I was shocked to see her covered in bruises. When I asked her, she broke down and told me how her in-laws beat her mercilessly when she refused to give them more money. My daughter, a bright law graduate, was reduced to a trembling shadow of herself. That day, they forced her to take ₹2 lakhs from us before returning to that hell house. For three years, we endured their constant demands - first for a car, then for cash, then for gold. Every refusal was met with violence. My daughter called me crying many times, telling how Sunny would come home drunk and beat her, how her mother-in-law would starve her, how they all tortured her mentally. We begged them to stop, but Sunny's political connections made the police turn a blind eye to our complaints. On that horrible day when Sunny called at 4 AM saying Dolly hanged herself, I knew immediately they had killed her. My daughter would never take her own life - she was planning to file for divorce and start a new chapter. The marks on her neck, the broken furniture in her room - everything shows this was no suicide. They murdered my baby because she finally refused to be their ATM anymore.

- The ligature mark is continuous, oblique, and above the thyroid cartilage, consistent with hanging.
- Eyes congested, tongue protruding and clenched between teeth.
- Salivary dribble stain noted at the angle of the mouth.

#### 2. Internal Examination:

- Neck structures: The hyoid bone and thyroid cartilage are intact.
- No evidence of hemorrhage in surrounding muscles.
- Lungs congested, with signs of pulmonary edema.

- Signs of Zopiclone drug.
- Other internal organs appear normal.

#### **Opinion:**

Based on the findings of the postmortem examination, the cause of death is **asphyxia due to hanging.** The manner of death is consistent with **suicide**.
