They reveal the lived realities of justice, inequity, and systemic biases, shedding light on marginalized voices often overlooked by dominant legal systems. Conversely, metanarratives, encompassing universal principles of human rights, justice, and equity, strive to create standardized frameworks that transcend borders, ensuring accountability and fairness on a global scale. This dynamic tension between local and global perspectives forms the crux of this dialogue.

The conference will address themes such as the impact of digital transformation on criminal law, including the proliferation of cybercrimes and the role of digital evidence. It will examine how narratives surrounding gender, race, and class influence the application and reform of criminal laws. Furthermore, the discussion will extend to international legal principles, such as the Rome Statute, and their integration into national systems, questioning how these frameworks accommodate or suppress local narratives.

By fostering interdisciplinary engagement among legal scholars, practitioners, policymakers, and activists, the conference aims to identify pathways for harmonizing micronarratives with metanarratives. It will focus on creating inclusive, adaptive, and just legal systems that respect cultural diversity while upholding universal standards of justice. **Objective of the Conference**

Formatting Guidelines for Paper

The research papers shall adhere to the following formatting guidelines:

- The length of the paper shall not be less than 5,000 and more than 8,000 words;
- The paper shall have an abstract of a maximum of 250 words with four to six keywords;
- The Heading of the paper shall be typed in Capital, Bold, Font Size 16, Times New Roman, centered aligned;
- The main body shall be in Times New Roman, Font Size 12, Line Spacing 1.5, Justified Aligned;
- Sub-headings shall be in Bold but shall not be in the capital with Font Size 12, Line Spacing 1.5, Justified Aligned;
- Sub-Sub Headings shall be in italics with Font Size 12, Line Spacing 1.5, Justified Aligned;
- Sub-sub-Headings shall be numbered with Roman numerals;
- Images shall be Central Aligned and with clarity, and authorities shall be duly cited, wherein case, if images are self-created, then such shall be mentioned as "Self-Created";
- All charts and tables shall be center-aligned, and the authorities shall be duly cited;
- APA style of referencing shall be used with both in-text citation and expanded referencing at the end.

Submission Guidelines

The participants shall strictly adhere to the following guidelines:

- Co-authorship for each paper is allowed up to two authors;
- No single author can submit more than one paper;
- The paper shall be uploaded in, or pasted in, the Google Form:
- In the case of two authors for the same paper, only one author shall fill up the submission form;
- All submissions shall be made through Google Forms.;
- Only Word files are accepted; PDF files shall be summarily rejected;
- The name of the document shall be saved by the title of the paper;
- All submissions shall be made within the due date of submission.
