**“U.N. HAS FAILED IN MAINTAINING INTERNATIONAL
PEACE AND SECURITY”**

RPNLUP's Debate and Discussion Club (DDC) is set to host its first international debate competition, bringing together sharp minds to engage in a thought-provoking discussion on the topic: *UN has failed in maintaining international peace and security*. This debate seeks to examine the effectiveness of the United Nations in addressing global conflicts, preventing wars, and ensuring stability across nations. The competition promises a platform for rigorous arguments, insightful perspectives, and to challenge conventional understandings of international governance.

ABOUT UNITED NATIONS

The United Nations (UN) is the most comprehensive international organization, bringing together 193 member states. Founded on 24 October 1945 after the devastation of World War II, it was created to foster global peace, security, and cooperation. Replacing the League of Nations, the UN emerged with a stronger and broader international consensus aimed at preventing future conflicts.

The UN Charter outlines its core objectives, including maintaining international peace, promoting friendly relations among nations, facilitating global cooperation on key issues, and ensuring collective action toward shared goals.

The UN operates through various main organs: the General Assembly, Security Council, International Court of Justice, Economic and Social Council, UN Secretariat, and the suspended Trusteeship Council. It is further supported by various specialized agencies, such as the World Health Organization (WHO), UNICEF, the United Nations Development Programme (UNDP), and the World Food Programme (WFP), which work to achieve its mission. Over the decades, the UN has contributed significantly to human rights advancements, humanitarian aid, sustainable development, conflict mediation, and environmental initiatives. Its peacekeeping missions and crisis responses, particularly in natural disasters, refugee movements, and pandemics, have proven vital.

Despite these achievements, major conflicts, including the Syrian Civil War, Afghanistan crisis, and tensions in Ukraine and Gaza, illustrate its limited ability to counter aggression. Its reliance on member states for resolution enforcement has led to selective implementation and frequent disregard. Bureaucratic inefficiencies, corruption, and political bias further undermine effective peacekeeping. The UN faces criticism, especially regarding the veto power held by the five permanent members of the Security Council, which often obstructs decisive action. As calls for restructuring grow louder, will the organization evolve to meet the demands of an increasingly complex world, or will its limitations lead to a shift in international governance?

Under the distinguished leadership of Hon'ble Vice-Chancellor Sr. Prof. (Dr.) Usha Tandon, the Debate and Discussion Club (DDC) of RPNLUP is flourishing as a dynamic platform that nurtures critical thinking, effective communication, and intellectual engagement among students. Rules & Regulations

Screening: Maximum 14 teams will be shortlisted. The shortlisting criteria of teams is mentioned under.*

Format: The debate is adhering to the classical format with a twist.

Eligibility: Undergraduate Law Students currently enrolled in any University of India and Abroad.

Rounds: There will be only two rounds – Preliminary and Final.

-Preliminary Round: The debate will begin with a preliminary round where all teams will compete. Topic for preliminary round is 'U.N. has failed in maintaining international peace and security'.

-Final Round: The top two teams from the preliminary round will advance to the final round. In the finale, teams will receive the topic on the spot. 20 minutes on the clock to prepare the topic. They may use mobile phones, laptops, and other resources to aid their preparation. Each team will be assigned to speak either for or against the motion. This assignment will be determined on the spot through a draw of lots.

*Selection Criteria for Shortlisting Teams

Participants will be selected on the following criteria-

- First-come, first-serve.
- Geographical diversity.
- Inclusivity.

General Guidelines

Language: The debate will be conducted in English Language.

Team Composition: Each University is allowed to send only one team to compete. There will be maximum of 14 teams. Each team will have two speakers: one will argue in favour of the motion, and the other will argue against it.

Speech Duration: Each speaker will be given 4 minutes to present their arguments. After the 4-minute speech, there will be a 1-minute grace period to conclude the argument.

Speaking Order: The order in which each team's speakers will present will be determined through a pre-event draw.

Question-Answer Round:

- Structured Interjection: Following each speech, there will be a structured interjection round.
- Questioning: Within this 1-minute interjection period, any member of the opposing teams or judges can ask one question.
- Response: The speaker must respond to the question concisely within 2 minutes.

Time Management: Participants must adhere to the allocated time for their speeches and the Q&A round. Exceeding this time will lead to deduction of marks or disqualification, depending on the judges' discretion.

Note: Further rules and regulations will be shared before the commencement of the competition.
