

#### PAPER SPECIFICATIONS

**Abstract:** Not more than 300 words and a minimum of five relevant keywords. The abstract must embody the objective of the paper, the broad argument(s), methodology, and the tentative findings.

**Paper:** Co-authorship is permitted to a maximum of one co-author. However, both authors need to register separately. In the case of co-authorship, at least one author must attend the conference to present the paper. No Proxy presentations are allowed. Both the author and co-author need to pay separately.

Maximum Length: 6000 words including title/cover page and references

Margins: 1" on all sides

Regular Font: Times New Roman, 12 points, Line spacing 1.5, justified

Title Font: Times New Roman, 14 points, bold, Line spacing 1.5

Footnotes: Times New Roman, font size 10 with a spacing of 1.0

Citation: Bluebook 20th Edn.

Similarity: Should not exceed 15%

Selected research papers will be published in an edited book form (Lex-Et-Mutatio) with ISBN Number. Two best research papers and one best presentation from each track will receive awards. However, papers not complying with the guidelines given above will not be accepted for publication.
