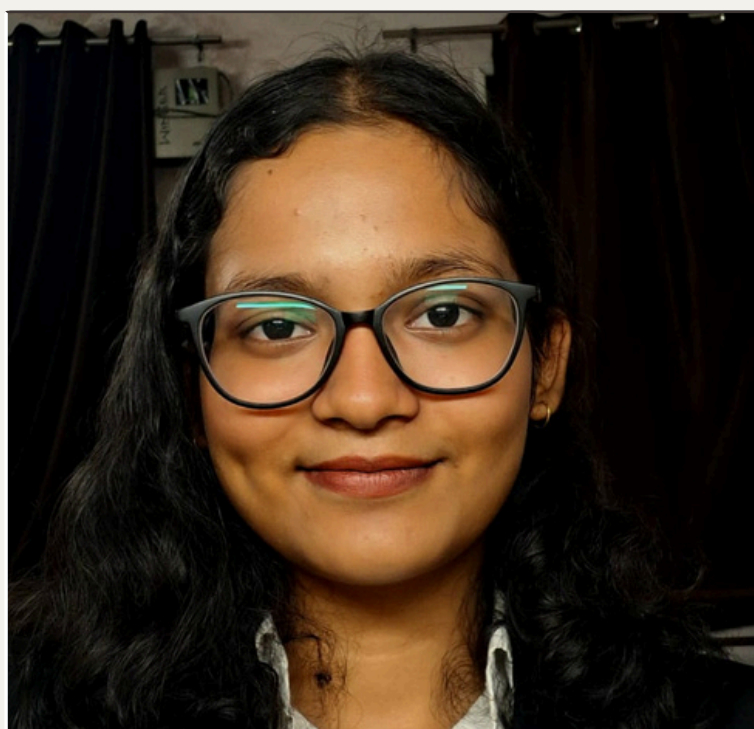

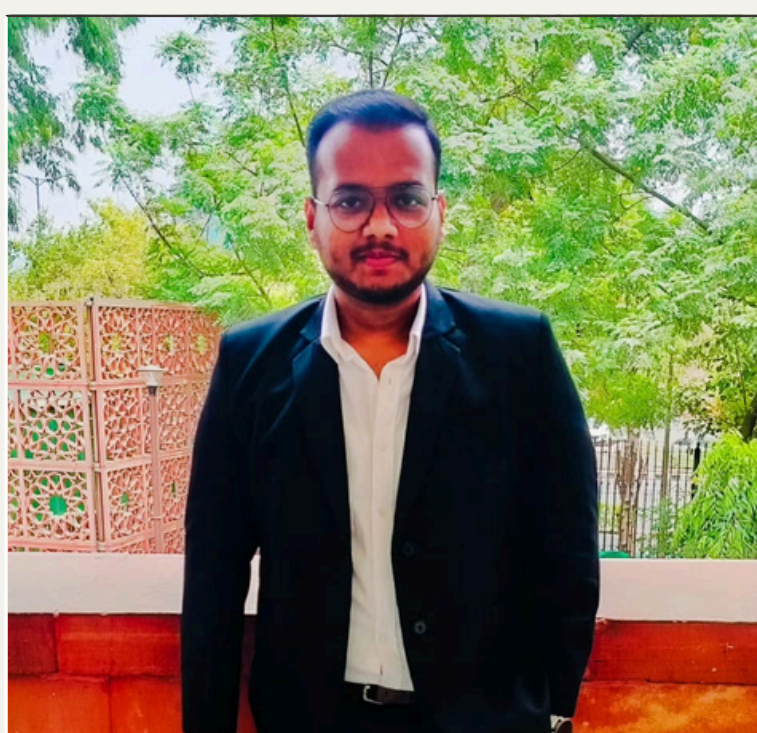

1. Basic Guidelines:

- a) After the successful registration, a confirmation mail will be sent to the participants, along with their team codes, and the participants will be added in a WhatsApp Group.
- b) The proposition of the **CHARGE FRAMING** and the **JUDGMENT** of **ROUND 1** would be shared to all the selected participants via mail and WhatsApp on **4th October 2025 by 9:00 am sharp**. The participants have to submit their framed charge and judgment, max to max till **2:00 pm sharp**, through the google form, which would be provided to you in the mail only. No extensions would be granted under any circumstances.
- c) The result of Round 1 would be shared to all the participants on 4th October 2025 by the evening.
- d) Out of all the participants, top 10 teams will be qualified for the Round 2.
- e) The proposition of the **CHARGE FRAMING** and the **JUDGMENT** of **ROUND 2** would be shared to all the selected participants via mail and WhatsApp on **5th October 2025 by 9:00 am sharp**. The participants have to submit their framed charge and judgment, max to max till **2:00 pm sharp**, through the google form, which would be provided to you in the mail only. No extensions would be granted under any circumstances.
- f) The final result would be declared to all the participants on 5th October 2025 by the evening.
- g) The decision of the jury members and the organizing committee will be final.

- Word Limit for the judgment: The submission shall not exceed 3,500 words (excluding footnotes and references).
- Formatting:
 - Font: Times New Roman
 - Font Size: 12
 - Line Spacing: 1.5 (Footnotes: Font size: 10, Spacing 1.0)
- Citation Style: 20th Edition Bluebook Citation
- Content Requirements:
 - Original and non-plagiarized content.
 - Submissions must simulate judgments aligned with Indian judicial standards
- File name: The Unique Team ID provided at registration (no other identifiers allowed).
- Format: PDF
- Identity Disclosure:
 - Submissions must not disclose the team's identity.
 - No logos, names, or affiliations of institutions.
