GENERAL INSTRUCTIONS



- There is no registration fee for the Competition; however, participants are required to fill the registration form located [here](#).
- The Competition is open to all students enrolled in an undergraduate or postgraduate program in any recognised university in India.
- To participate in the Competition, interested students must register using the registration form. Late registrations shall not be accepted under any circumstances.
- Any copyright infringement/plagiarism shall result in automatic disqualification. The organisers reserve the right to recall any prize if it is discovered later that the article suffered from any copyright infringement/plagiarism.

GENERAL INSTRUCTIONS



- Once the article has been submitted, all intellectual properties and royalty-free publication rights of the article shall be transferred to the organisers.
- The Article shall be considered to be a property of the organisers, which reserves the right of publication of the same as it may deem appropriate.
- Any further publication after the declaration of results shall only be pursued after express permission from the organisers.
- No part of the Article should contain any form of identification of the participant such as the name of the author, University/College name, etc. in the document. Any form of identification will lead to disqualification.

GENERAL INSTRUCTIONS



- By entering the Competition, the participants agree to indemnify the organisers from and against all claims, suits and damages based on any claim of copyright infringement or plagiarism or unauthorised use.
- If there arises any situation that is not contemplated in the rules, the organisers' decision on the same shall be final and binding.
- The winners of the Competition authorise the organisers to use their names and photos, if required, for the purpose of publicising the Competition and its results.
- The administration of the Competition, including determining the eligibility of any participant or Article, evaluation of Articles, and awarding of the prizes, is within the sole and absolute discretion of the organisers.

THEMES



Articles will be accepted on any topic provided that it is of recent relevance and a significant development in the legal fraternity. The following are the broad themes suggested-

1. Criminal and Procedural Laws

2. Constitutional Laws

3. IPR and Technology Laws

4. Business and labour laws

5. Environmental, Space and Aviation laws

6. Any other topic of legal interest

SUBMISSION GUIDELINES



- All submissions should be made in the designated electronic form shared via email after the registration has been confirmed.
- The Article must be written in English and submitted in both Microsoft Word document format (.doc/.docx) and PDF format.
- Co-authorship up to a maximum of two authors is permitted. Only one submission is allowed per author/team.
- Submissions, both as co-author and single, will be treated as multiple submissions and will be disqualified as an entry to the competition.
- The Article must contain an abstract, not exceeding 200 words (which would not be counted in the word limit for the Article). It must indicate the theme.

SUBMISSION GUIDELINES



- The Article must be accompanied by a the following information about the participant in the first page of the document: (i) full name of the participant; (ii) theme chosen; (iii) participant's current year of study and name of the degree pursued; (iv) name and full address of the participant's university; (v) name and full postal address of the participant; (vi) phone number of the participant; and (vii) email ID of the participant.
- The Article must be original and bonafide work of the participant.
- The word limit is 1500-2500 words excluding footnotes. Footnotes must follow the Bluebook system of citation (Harvard, 20th edition).
- Reference or paraphrasing of thoughts and ideas from standard works are acceptable without quotations, provided they are duly acknowledged in footnotes or otherwise as may be suitable.

SUBMISSION GUIDELINES



- Incomplete or plagiarised submissions shall be summarily rejected. The plagiarism limit is 15% (excluding footnotes).
- The Article should not be submitted as a part of this competition anywhere else for any other purposes.

The article must adhere to the following formatting guidelines:-

- **Headings:** Font – Times New Roman and Font Size – 14
- **Main Body:** Font – Times New Roman, Font Size – 12, and Line Spacing – 1.5.
- **Footnotes:** Font – Times New Roman, Font Size – 10, and Line Spacing – 1.0.
- Margins should be 1 inch or 2.54 cm on all sides.

EVALUATION CRITERIA



Articles will be evaluated by a panel of distinguished evaluators, The criteria will be the following

- Clarity and content (30%),
- Originality and relevance (25%),
- Structure and flow (20%),
- Presentation (15%), and
- Effectiveness in communicating the message (10%).
